ACCC Surveys Member Hospitals on Costs and Reimbursement of Cancer Drugs

o educate Congress and the Centers for Medicare and Medicaid Services (CMS) about the true costs of cancer drugs to hospitals, ACCC is working with Abt Associates to conduct a survey of its 650 member institutions. In July and August, ACCC's member institutions were asked to provide information about 1) invoice prices of cancer drugs, 2) invoice prices after any rebates, 3) charges for cancer drugs, and 4) volume of cancer drugs used. This information will be used to compile an analysis of the real costs of cancer drugs in the hospital setting. ACCC will use this study to support its efforts to correct 2002 Medicare payment rates and to ensure that, in 2003, Medicare adequately reimburses hospitals for cancer care, allowing Medicare beneficiaries to access the drugs they need. The study will be completed in September 2002.

REGIONAL ONCOLOGY REIMBURSEMENT SYMPOSIA

CCC's series of Spring 2002 Regional Oncology Reimbursement Symposia ended on June 19 with a final regional meeting held in Pittsburgh, Pa. Open to all cancer care professionals, the regional meetings provided attendees with regulatory and legislative updates related to cancer care delivery. More than 400 people attended the five regional sessions held in Des Moines, Ia.: St. Louis, Mo.: New Orleans, La.; Baltimore, Md.; and Pittsburgh, Pa. During the past 11 years, ACCC has hosted more than 130 Regional Oncology Symposia in conjunction with state medical oncology societies. These meetings have now become a tradition and are highly sought by state medical oncology societies, which use them as a core for annual society meeting activities. Five regional meetings will be held this fall and are tentatively being planned for Indiana, Nebraska, New Jersey, New York, and Washington. 🗣
