ACCC's 35th Annual National Meeting— A Pictorial

March 18-21, 2009 Gaylord National Resort & Convention Center National Harbor, Md.

Keynote speaker Gerald A. Kraines, MD, spoke on accountable leadership and the cancer care team: to be effective, leaders need both authority and accountability.





ACCC's Annual Achievement Award recipient Susan Leigh, RN, BSN, pictured with ACCC President Ernest Anderson, Jr., MS, RPh, (left) and ACCC Executive Director Christian G. Downs, JD, MHA. Ms. Leigh accepted the award on behalf of "all cancer survivors across the country." Ms. Leigh is a founding member and past president of the National Coalition for Cancer Survivorship (NCCS). She initiated the formation of the Oncology Nursing Society's Nurse Survivors Focus Group and the Survivorship Special Interest Group. Ms. Leigh is a survivor of Hodgkin's lymphoma and breast and bladder cancers.



Meeting attendees benefited from both general sessions, smaller break-out sessions, and roundtable discussions. On Friday afternoon, attendees heard a report from Mary Lou Bowers, MBA, of the Pritchard Group, on Phase 1 of ACCC's ongoing *Prostate Cancer Project* followed by a panel presentation highlighting some best practices in developing a prostate-specific cancer program.







On the opening day of ACCC's Annual National Meeting, attendees (at right) heard from Congressman John Sarbanes (D-MD) (center) and Congressman Tom Price (R-GA) (on left). Both congressmen agreed that in recent years a consensus has been reached that the healthcare system is broken and this is a critical year for healthcare reform. Hearings are already in progress on Capitol Hill. While anticipating "a fair amount of contention among the different players in this game," Rep. Sarbanes expects that ultimately healthcare reform will help better align incentives and create a "transformative system...one that puts patients and providers in the driver seat when it comes to deciding healthcare in this country." Congressman Price expects that the coming reform will change healthcare for at least a generation. Rep. Price favors a "patient-centered" healthcare system in which everyone owns and controls his or her own insurance policy, and where a "robust peer-review process—not the government—ensures quality."
