Overcoming Key Challenges to Lung Cancer Clinical Trial Recruitment and Retention

Only 14 percent of patients with lung cancer are aware of clinical trials as a treatment option, and fewer than 10 percent of patients with lung cancer are enrolled in clinical trials. This activity will illustrate the importance of clinical trial enrollment and retention in advancing patient care, explain potential barriers that impact enrollment in clinical trials, and discuss strategies that can be used to overcome challenges in recruiting and retaining participants in lung cancer clinical trials.
