


Millions of Voung Adults Covered Because of Healthcare Reform

From Sept. 2010 to Dec. 2011, the percentage of adults ages 19 to 25 with insurance coverage increased from 64.4% to 74.8%, according to the National Center for Health Statistics. This means about 3.1 million young adults have obtained health insurance coverage as a result of the Patient Protection and Affordable Care Act, which requires insurers to allow adults to stay on family policies until age 26.



HEALTH CLAIMS ERROR RATE CUT IN HALF, **CREATING \$8 BILLION IN SAVINGS**

The error rates paid on medical claims declined from 19.3% in 2011 to 9.5% in 2012, resulting in huge savings to the health system, and avoiding unnecessary administrative tasks associated with reprocessing inaccurate claims. Medicare and all seven private insurance companies reviewed in the AMA study made improvements across various quality, timeliness, and accuracy metrics.
