Theme Set For ACCC Spring Meeting

"The Impact of Managed Care & Health Reform on Oncology," will be the theme of the ACCC's 19th Annual National Meeting, to be held in Washington, DC, on March 17-20, 1993. Scheduled sessions include:

- The impact of managed care for clinical trials, new technology, risk management, outcomes research, the pharmaceutical industry, and the future of biotechnology.
- How cancer programs should market their services to managed care organizations.
- Negotiating managed care contracts: the hospital perspective and the private practice perspective
- Updates on health care reform proposals by representatives of the new Administration, Congress, and academia.

Other sessions will include an update on physician profiling by the insurance industry, how to build communities in the workplace, how to successfully recruit medical oncologists and medical directors, and how to develop a breast center. There will also be a new technology symposium.

Call For Bylaws Amendments

ACCC Bylaws, adopted March 1984 by the House of Delegates, state: "Bylaws may be amended by the vote or written assent of two-thirds of the Delegate Representatives voting. Written notice of proposed bylaws amendments must be sent to voting members at least 30 days prior to the meeting at which they are to be acted on."

ACCC's CRG: An Update

The ACCC's Collaborative Research Group (CRG) recently held meetings of the entire membership, as well as the steering committee. The membership discussed potential affiliations with two new companies. John W. Yarbro, M.D., Ph.D., the CRG Principal Investigator, shared some of his insights on the successful recruitment of patients. There are now 46 CRG member institutions and applications from an additional four institutions are in the review process.

Robert Knight, M.D., CIBA-GEIGY medical monitor for Aredia protocol #12 (multiple myeloma), discussed progress of three ongoing studies with the group. The 18 sites that have been activated for the three CIBA-GEIGY studies report that as of mid-September, 45 patients have either been accrued or identified as meeting the eligibility criteria and are ready to be placed on study. An additional four patients have been screened as potential study participants.

A staff survey of member organizations was conducted in the summer to determine how many institutions have bone marrow transplant (BMT) units. The survey found that eight (8) sites have established BMT units (8 autologous and 4 autologous and allogeneic). Since those units have opened, there has been an average of 46.25 patients transplants performed per site. Ten additional institutions are in the process of developing BMT programs.

Minnesota Chapter Holds Elections

The Minnesota Society of Clinical Oncology, an ACCC chapter member, recently held elections for officers and executive board members.
