KEEPING UP TO DATE ON REIMBURSEMENT

Six Regional Reimbursement Meetings will be held this fall, beginning with the October 12, 1995, meeting in Minneapolis, Minn. Cosponsored by ACCC and state clinical oncology societies, these meetings are designed to create a forum in which reimbursement policies affecting the care of cancer patients can be discussed with the major insurers. Attendees at these oncology symposia learn how guidelines, managed care, integration, and other system-wide changes are altering the practice of oncology.

CALL FOR AMENDMENTS TO BYLAWS

Any delegate representative who wishes to suggest a bylaws change must inform the ACCC Executive Office of that intent no later than December 1, 1995, for consideration by the House of Delegates in March 1996. According to the ACCC Bylaws, adopted March 1984 by the House of Delegates, "bylaws may be amended by the vote or written assent of two-thirds of the Delegate Representatives voting. Written notice of proposed bylaws amendments must be sent to voting members at least 30 days prior to the meeting at which they are to be acted on."
