ACCC Executive Director Lee E. Mortenson, D.P.A. (right), presents the Edward L. Moorhead Award to Jamie Young, former ACCC director for state societies and government relations (1991-1998), in recognition of his significant contributions to improving cancer treatment in the community. Young worked with state legislatures across the country to help enact new laws and administrative rules ensuring cancer patients access to “off-label” uses of drugs. The award is named after Edward L. Moorhead III, M.D., a pioneering ACCC leader who championed the involvement of community oncologists in clinical trials.

“The opportunity to work for ACCC and represent all of you across the country is an honor,” Mr. Young told meeting attendees. “This award is for all of us, for all we have accomplished in such a short time. In 1991 two states had laws that addressed off-label drug coverage. It’s now up to 31, an amazing success story!”
