2022 Legislative Session

- 2022 Hawaii State Legislature convened 1/19/2022 and ended on 5/5/2022
- On behalf of HSCO, monitored and lobbied on several healthcare bills related to mammography insurance drugs, and fertility preservation for cancer patients.

2022 – Fertility Preservation

Under Hawaii law, to pass a bill that mandates additional health insurance coverage, the Legislative Auditor must conduct a social and fiscal analysis of the proposed benefit before a bill can be passed.

2022 - Mammography

- <u>HB1774 and SB2635</u>: Description : Requires health insurers, mutual benefit societies, and health maintenance organizations to cover mandated services for mammography at least as favorably as coverage for other radiological examinations.
- <u>SB2635</u> Passed both House and Senate, but died in the final days of session in conference committee
- HSCO Testified in strong favor of the bills,
- Bills are expected to be re-introduced next session



2022 – Mammography – Part 2

- HCR33: Description: Requesting the Auditor to conduct a social and financial breast cancer screening
- Passed both House and Senate and ADOPTED.

2022 – Telehealth

Multiple bills were introduced and moved on the issue of telehealth with a

• HB1980: Description: Permits, but does not require or prohibit, Medicaid, organizations to cover telephonic behavioral health services under certain circumstances. Clarifies that telephonic services do not constitute telehealth.

Although the bill clarifies when telephonic services may be covered, and provides guidance to health insurance providers, the final bill may be interpreted to strictly limit insurance coverage for telephonic

HSCO Testified in favor of the bills to establish parity for telehealth more





2022 – Pharmaceutical Drugs

- The Legislature looked at the pharmaceutical drug industry to see how there can be better transparency and regulation on the prices of drugs. These bills were aimed at the pharmaceutical manufacturers, pharmaceutical benefit managers (PBMs), and health insurance plans.
- Due to the complexity of the issues, none of the bills introduced passed.
- HSCO Testified in strong favor of the bills,
- Bills are expected to be re-introduced next session \bullet





2022 – Medical Aid in Dying

HB1823: Description: Authorizes advanced practice registered nurses and physician assistants to practice medical aid in dying or provide counseling to a qualified patient. Requires an attending provider to make an initial determination in person or via telehealth. Amends the mandatory waiting period between oral requests and the provision of a prescription. Prohibits the disclosure, discovery, or compelled production of information collected or retained pursuant to incidental or routine communication between DOH and qualified patients or providers.

• Died in conference. Expected to be re-introduced next session.
