Why State Advocacy?

 Legislative action at the state level is increasingly shaping cancer care and the practice of oncology.

A law enacted in one state can create a model for other states.

States serve as incubators for federal policymaking.

VAHO/ASCO Engagement: 2023 Session

- Prior Authorization (HB 1471/SB 1261) requires each health insurance carrier to establish and maintain an electronic prior authorization process (Enacted)
- Fertility Preservation (HB 2366/HB 1876) —requiring coverage of fertility preservation services for patients with cancer and for firefighters respectively (Both Failed)
- Short Term Limited Duration Plans (SB 1336) would allow for short term limited duration health insurance plans to be renewed for up to 36 months (Failed)



Virginia Elections: What to Watch

- All House and Senate members are up for election in November, many in new districts
- We expect an estimated 50% turnover in the House and Senate
 - Educating newly elected members about cancer care will be important
- The balance of the Legislature could change
 - Democrats control the Senate, Republicans control the House and Governor's mansion
 - Political breakdown post-election will determine committee leadership



Virginia's 2024 Legislative Session

- Session beings January 10, 2024
- Virginia has speedy legislative sessions 60 days in evennumbered years and 45 days in odd-numbered years
- Virginia operates under a two-year budget cycle
 - Initially adopted in even-numbered years and amended in oddnumbered years – 2024 will be a budget year



Looking Ahead to 2024

 Non-medical switching legislation – would prevent a plan from requiring a patient to switch to a cheaper drug when they're already stable on their current prescription

 Out-of-Pocket costs legislation – would cap out-of-pocket expenses for prescription drugs
